

From the Park Manager

I hope everybody had a joyous holiday season!

Most of our traditional park patrons are hunkered down waiting for warmer weather. Still, this can be a very enjoyable time for a walk in the park. The tall and abundant grasses sway in the breeze; the abundant wildlife, particularly white tail deer, are easy to see through the dormant vegetation; and the serenity you fell while waking in the woods or along the river when there are few, if any, other people you encounter is hard to describe!

Paid park staff and volunteers remain very busy with public hunts (the first two weeks of January), refurbishing and remodeling facilities (the amphitheater is getting a face lift to make it more inviting to park guests and to be used as a year-round interpretive and guest services center), training (first aid and CPR, customer service, and interpretation), and planning (short and long term, the latter to include a request for a new master plan so the park can adequately meet the challenges it will face over the next several decades). Immediate challenges we (The Friends and Texas Parks and Wildlife) must meet are completing revisions to the Memorandum of Agreement between The Friends and Texas Parks and Wildlife and getting the document signed so we have a valid working agreement; getting and keeping the word out about the Friends so we can increase membership and participation and therefore increase programming and fundraising capabilities; developing criteria for the Honey Creek tours and training or

re-training tour guides so that the main messages we convey on these tours is consistent and meaningful; and moving forward on new education and park operations projects. I know we all bring enthusiasm and great ideas to the process; we will accomplish good things; our park guests will have an improved park experience as a result of our efforts; and we will have some fun along the way!

I'm looking forward to seeing and working with everybody in January and into the spring.

New Projects are in the works! In this new year we are hoping to complete a few projects in the park including: installation of information kiosks at key locations in the park, maintenance work and repainting at the Rust House, and improvements to parts of the Honey Creek trail. Volkswalk There will be a Volkswalk event at Guadalupe River S.P. and Honey Creek S.N.A. on February 15-16 sponsored by the American Volksport Association (AVA). The walk will include two 10kilometer (6.3 mile) walks. The walk route is open to everyone, AVA and non-AVA members alike. Standard park entry fees will apply. This will be a great opportunity for families to get out together while getting some exercise and enjoying the scenic beauty of the State Park and State Natural Area, the latter normally only being accessible by guided tour. If the weather is good we expect about 500participants.
