A Word from the President

A year has passed since we reorganized the Friends of Guadalupe River/Honey Creek Inc. It has been a rewarding year for me. We have a dedicated working board of directors and officers. We have laid the groundwork for many new opportunities for the Friends. The park staff has been supportive of our efforts. The organization is moving in the right direction. When I visited with Mark last summer I expressed that as my goal for this year. I see the coming year as a pivotal period for the Friends. We can continue to meet and provide money and projects to assist the park or we can do so much more.

This past year we had discovered the State Comptrollers Office had earmarked 750 acres of park land on the north side of the Guadalupe for possible sale. The park manager Mark Abolafia-Rosenzweig worked with the "Friends" to develop a utilization plan for that area and, I am relieved to say, that although two other parcels of state park lands were sold, Guadalupe River Park property was removed from the list. It is our challenge now to follow through with plans to make this area available for public use without any additional funds from the state. I would like for each member of the Friends to become involved in some way to help the Friends accomplish our goals. There are several ways this can happen. 
Honey Creek Eagle Scout Project Completed!

From the Park Manager's Desk

By the time you read this Labor Day weekend will have passed, and with it, another busy season and fiscal year will be behind us. Our fiscal year is September through August and our visitation is up about 5% and revenue up about 19% for the year compared to last fiscal year.

We will have many challenges again this year:

1. We will have several key staff changes. Tommy Asher, our Lead Park Ranger retired August 29th with over 30 years of TPW experience, the last 20+ being here at Guadalupe. We will miss his experience and his ability to be a great team player. We are in the process of filling our Utility Plant Operator position which has been vacant since last October and the Assistant Manager/Park Peace Officer position which has been vacant for over two years.

2. Our new park entrance gate has finally been completed. I really appreciate The Friends supporting this project. We have already received several great comments from our guests about this upgrade. The gate automatically closes at 10 p.m. and opens at 8 a.m. each day, saving us at least five staff hours a week. For guests, the gate opens automatically to exit and there is no more fumbling with the gate lock on dark nights to get in creating a much safer and comfortable experience as most guests can open the gate from within their vehicle – a real plus, particularly on rainy, cold, or lightning filled nights.

3. By our September Friends meeting I should have our Fiscal Year 2004 budget in hand. The good news is that I expect our budget will be roughly on par with our FY 2003 budget. The bad news is that it does not provide enough funding to fix everything that breaks or nearly enough staff to provide consistently good customer service during our busiest periods.

4. Guadalupe River State Park and Honey Creek State Natural Areas will jointly go through the master planning process this year as one of four parks or park complexes in the State identified as immediate priorities. This is a tremendous opportunity to have an input on plans for these sites that are likely to be in place for the next 20 years! I'm sure The Friends, as well as other local interested "stakeholders" will have opportunities for input in this process.

The fall and winter will be a time for staff renewal - figuratively and literally – as we look at what we want and are able to accomplish this next year. Our ability to accomplish many things will greatly depend on the commitment of our Friends to provide continued financial and volunteer support to existing programs and new program ideas. My first full year as manager of Guadalupe River State Park and Honey Creek State Natural Area has come to a close. I've had a great time. Work has been very fulfilling and my family is flourishing in this area. I'm looking forward to this next year and meeting the upcoming challenges with my Friends!

URGENT MESSAGE: from the Editor

The Friends of Guadalupe River/Honey Creek, Inc. need your help! It has come to my attention that presently, there are only 27 paid members in the organization! If you wish to remain or become a member and receive the quarterly newsletter, <u>please</u> fill out the attached membership form and return it with your check to the address provided. We need every interested person to become an actively involved Friends member in order to save our park land and accomplish our goals.

The Friends and park management have been developing an interpretive master plan for Guadalupe River State Park and for Honey Creek State Natural Area that will give us direction in planning recreational activities, educational programs, historical restoration and facility construction. The rich cultural heritage we have in this area of Native American, Spanish, Mexican and German peoples will become part of the basis of our planning.

Several suggestions have been made as to what development should take place here. Some of these are: 1. build a large group pavilion for school children and private gatherings, 2. provide access and development to the north side of the river (which would triple the river front access), 3. restore one or both of the German homesteads located on park property as living history facilities, 4. restore and utilize a historic structure as an environmental education and research center. These are just a few of the many ideas that have come forth for improving and developing this valuable free space resource we have in this rapidly urbanizing area.

As you can see, these are very lofty goals, especially viewed from where we are today. However, with the participation of interested citizens and organizations, these dreams and goals can be reached. We are in a serious position of losing 750 acres of beautiful riparian land if we do not utilize it properly. A small group of 27 families cannot accomplish the task alone. Please join us at our Annual Meeting and Pot Luck Dinner, September 18 in the Amphitheatre, and bring along some friends. Become part of something truly special!
